- 第 一 條 廣亞學校財團法人育達科技大學(以下簡稱本校)為吸引優秀境外學生來校就讀，並協助其在校就學期間減輕生活負擔，特設置境外學生獎助學金(以下簡稱本獎助學金)，訂定本辦法。
- Section One Kwang-Ya School Corporation Yu Da University of Science and Technology(YDUST) sets up Overseas Student Scholarship to attract outstanding students to enroll in YDUST as well as to help them relieve the burden of living.
- 第 二 條 本辦法所稱境外學生係指具備本校正式學籍之僑生、大陸地區、香港、澳門及外國籍學生(不含特殊專班學生)。
- Section Two Overseas students in this scheme means regular students of YDUST who are overseas Chinese students and who are from Mainland China, Hong Kong, Macau, and other countries (excluding special class students).
- 第 三 條 未領有國內、外公費獎助學金者，得依本辦法規定申請獎助。但延修生除外。
- Section Three Except for delay graduated students, those who do not receive any domestic or foreign public-expense scholarships can apply for this scholarship.
- 第 四 條 本辦法每學年度所需經費，由國際事務處(以下簡稱國際處)編列預算。經費來源依本校學雜費提撥學生就學獎助學金支應之。
- Section Four The fund of this scheme is budgeted by the Office of [International Affairs \(OIA\)](#). The fund of this scholarship comes from the tuition and incidental fees of YDUST.
- 第 五 條 獎助學金金額：
- 一、新生入學助學金：新臺幣 1 萬 5 仟元整。
 - 二、優秀獎學金：新臺幣 1 萬 5 仟元整。
 - 三、特殊專班學生、國際交換生或與本校簽訂合作意向書之教育機構所推薦

之學生獎助學金可依專案簽陳校長同意後辦理。
前項獎助學金每學期以領取一項為限，於註冊後核撥。

Section Five

Scholarship Amounts:

1. Freshman Admission Scholarship: NT\$15,000.
2. Excellence Scholarship: NT\$15,000.
3. Scholarships for Students in Special Programs, International Exchange Students, or Students Recommended by Educational Institutions with an Intent to Cooperate Agreement Signed with YDUST can be processed upon approval by the President in accordance with the specific project proposal.

Applicants are limited to receiving one scholarship per semester, which will be disbursed after registration.

第 六 條

境外學生符合下列資格條件，得於規定期限內，向國際處提出申請：

- 一、新生：在前一學制畢業學校就讀之每學期成績經依本校學則規定或其他通用成績轉換辦法換算後平均六十分以上，學業成績總平均七十分或 B 等（GPA3.0）以上者。國際專修部學生除外。
- 二、舊生(碩士班學生)：前一學期學業成績平均需達八十分(含)以上、操行成績需達八十五分(含)以上、缺曠課不得超過總修課時數五分之一。
- 三、舊生(大學部學生)：前一學期之學業成績平均需達七十五分(含)以上、操行成績需達八十五分(含)以上、缺曠課不得超過總修課時數五分之一。

Section Six

Overseas students who meet the following eligibility criteria may apply to the Office of International Affairs within the specified deadline:

1. New Students: Applicants must have an average grade of 60 or above for each semester in their previous educational institution (calculated according to YDUST academic regulations or other standard grade conversion methods) and an overall academic average of 70 or a B grade (GPA 3.0) or above. This excludes students in the International Foundation Program.
2. Current Students (Master's Program): Applicants must have achieved an average academic grade of 80 or above and a conduct grade of 85 or above in the previous semester. Additionally, absences must not exceed one-fifth of the total class hours.
3. Current Students (Undergraduate Program): Applicants must have achieved an average academic grade of 75 or above and a conduct grade of 85 or above in the previous semester. Additionally, absences must not exceed one-fifth of the total class hours.

第 七 條

本獎助學金申請期限如下：

- 一、新生應於入本校就讀後一個月內提出申請。
 - 二、舊生應於每學期開學後一個月內提出申請。
- 但有特殊情形，實際日期以本校國際處公告時間為主，逾期不予受理。

Section Seven

The application deadlines for this scholarship are as follows:

1. New students must submit their applications within one month after enrolling at YDUST.

2. Current students must submit their applications within one month after the beginning of each semester.

In special circumstances, the actual dates will be based on the announcements from the Office of International Affairs of YDUST. Late applications will not be accepted.

第 八 條 申請獎助學金者，應繳納下列證明文件：

一、新生：申請碩士班請附大學歷年成績單，申請大學部請附高中歷年成績單(中、英文以外之語文應附中文或英文譯本)、學生證影本(需加蓋當學期註冊章)或教務處所開立之在學證明。

二、舊生：前一學期之學業成績單一份、學生證影本(需加蓋當學期註冊章)或教務處所開立之在學證明、學務處提供之缺曠課紀錄。

Section Eight Applicants should submit the documents as follows:

1. New students: Applicants for Master's programs must provide their complete undergraduate academic transcript. Applicants for undergraduate programs must provide their complete high school academic transcript (transcripts in languages other than Chinese or English must include a Chinese or English translation). A photocopy of the student ID card (stamped with the registration seal for the current semester) or an enrollment certificate issued by the Academic Affairs Office.

2. Current students: A copy of the academic transcript for the previous semester; a photocopy of the student ID card (stamped with the registration seal for the current semester) or an enrollment certificate issued by the Academic Affairs Office; attendance records provided by the Student Affairs Office.

第 九 條 受獎學生注意事項如下：

一、受獎助學生，如經查證有偽造或不實之情事，應撤銷其受獎資格。

二、受獎助學生在受獎期間，因退學、休學、轉學、提前畢業或曠課時數超過總修課時數三分之一之情形者，應取消其受獎助及申請資格。

三、受獎助學生領取獎助學金後，如有重大違規之行為，應取消下一學期之受獎資格。

Section Nine Notes for Scholarship Recipients:

1. Scholarship recipients found to have submitted falsified or inaccurate information shall have their scholarship eligibility revoked.

2. Scholarship recipients who, during the scholarship period, withdraw from school, take a leave of absence, transfer to another school, graduate early, or have absences exceeding one-third of their total class hours, shall have their scholarship and application eligibility revoked.

3. Scholarship recipients who engage in major violations after receiving the scholarship shall have their eligibility for the following semester's scholarship canceled.
